


And whereas if any vacancy made in Board of Trustees these vacancy can be full filled by co-option.

#### NOW THIS INDENTURE WITNESSETH AS FOLLOWS:-

1. That in order to effectuate his aforesaid desire the settler has set apart and handed over to the trustees , a sum of Rs 100000/-(One Lac ) (herein after called the fund which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part thereof -

#### 2. THAT THE OBJECT FOR WHICH THIS TRUST IS ESTABLISHED ARE:-

- (A) To organize, promote, undertake all programs for the foundation of fearless and non-succumbing society on the basis of truthfulness & non-violence.
- (B) To organize, promote, undertake, sponsor, carryout all programs for the benefit of naturally-challenged person, schedule caste, schedule tribes, people under poverty line, old aged, widow and down trodden irrespective of the caste, creed, sex and religion such as

#### I. IN THE FIELD OF HUMAN RESOURSE DEVELOPMENT:-

- a) To establish, develop, maintain school, colleges, libraries, universities, laboratories, skill development center, yoga and spiritual center, sports training center, vocational training center, research and other institutions or the development and advancement of education and diffusion of knowledge among the public in general.
- To establish maintain and run engineering college, pharmacy college, dental college, paramedical college, polytechnic college, B.Ed. college, nursing college, I.T.I college (NCVT), Amant Training Institute Skill Development Training Center & others.
- c) To establish, maintain and run studentship, scholarship and award programs and render other kind of aid to the students including supply of study materials, books, stipend, medals and other incentives.
- d) To organize program for the promotion of pre-primary education, nonformal education, computer and information technologies, leadership development, educational infrastructure, research and development, socio-scientific research, management.
- e) Publish study materials , magazines , books , information materials , journals , produce film , T.V. serials , documentaries, audio visual cassettes ,C.D's / soft copies on burning educational and scientific issues

#### II IN THE FIELD OF YOUTH AFFAIRS AND SPORTS:-

- (a) To carry out all the programs / projects for the awakening of national integration , communal harmony , co-operation and co-operative behavior attitude development , moral and social habit development in the youth and to ensure participation in the development of nation and humanity.
- (b) To organize and install infrastructure for the promotion of sports, yoga , meditation & organize cultural programs, music, dance programs and training center in the field of art and culture.

#### III IN THE FIELD OF HEALTH AND FAMILY WELFARE:-

- To undertake, establish, assist, organize or conduct the programs of research, management and infrastructure, development in the field of health and family welfare.


#### VII IN THE FIELD OF SCIENCE & TECHNOLOGIES

#### AND COMMUNICATION & INFORMATION TECHNOLOGIES:-

- To carry out all the programs of science and technology and communication technology for popularization, use and inculcation of scientific temper among the people also ensure the use of technology in the field of rural development appropriate technology, rural technology, environment and ecology, non-conventional energy, formal education, computer education. -
- All the activities shall be non-profitable and shall be done on no profit and no 3. loss basis."
- 4. All the incomes earnings, movable / immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and objectives only as set for in the deed of the trust and no profit there of shall be paid or transferred directly or indirectly by way of dividends bonus, profits or in any manner whatsoever to the present or the past member of the trust or to any person claiming through any one or more of the present or the past members. No members of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits whatsoever, by virtue of his/her membership. \*
- 5. That the trust fund may be augmented by the income from initial funds also by donation and other contribution from time to time.
- 6. That the trust fund shall not be applied for any purpose other than those specified in para-3 herein above unless the other objects added to the trust objectives.-
- 7. That the trustees shall always maintain proper accounts of the trust, which shall be kept at the office of the trust.-

- Subject to the provisions of income tax act. 1961 as amended from time to 8. time, the trustees will keep the trust fund of such portion there of as they may in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other property for any loss invested in such shares, stock, securities and debentures of acquisition or construction of any immovable property in India, of free hold or lease hold tenure and may deposit the amounts with any scheduled bank, company, or private firm any individual on such terms and conditions as they think fit in the matter of investment of trust funds, the provisions of section 20 of the Indian trust act shall apply, in the event of trustees purchasing any immovable property or advancing money's or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The trustees shall have power, if any deed in their absolute discretion to sell the trust fund or any part there of any such immovable property purchased by them under the power of aforesaid and any other shares, securities, etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon the trusts and with the subject to powers and provision including and all the posers contained by and under these presents declared and contained concerning the trust fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.
- That for the furtherance of the trust, the trustees shall have the following powers:-
- (i) To accept any donation, contribution loan grant or subscription in cash or in kind, from any person(s) or association of person(s) or body corporate or trust with or without conditions.
- (ii) To apply the whole or any part of the income of the trust, or the trust fund of accumulations there to any one or more or the objects of the trust, as the trustees may in their discretion, dream fit from time to time.—
- (iii) To sell, dispose of alienate or otherwise deal with any property comprising the trust fund.
- (iv) To open account in the name of trust, with a band or bank to operate such account and to give such instructions to the bank and to provide for opening the operation of such account by one or more trustees or by an agent appointed by the trustees.
- (v) To adjust, settle, compromise, compound refers to arbitration, all actions, suits claims demands and proceedings regarding the trust funds.
- (vi) To engage or make provision for the engagement of any person (including all or any of the trustees and committees or administrator or settler cum presidents or otherwise) for the

purpose of the administration of the trust in such manner and subject to such rules and regulation as the trustees may prescribe and also to engage or provide for the engagement.

- (vii) To make very alter or modify schemes, rules and regulations for carrying out the objects of the trust and for the management of the affairs there of and / or running any institutions with furtherance of the objects of the trust and otherwise for giving effect to the object of the trust.
- (viii) To start, abolish, discontinuations and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.—
- (ix) To set apart and / or allocate the whole or a part of the income or the corpus of the trust fund or the part there of for any of the objects of the trust.—
- (x) To join , to operate or amalgamate this trust with other of others having kindred or allied objects , upon such terms and conditions as the trustees may in their discretion think fit particularly having regard to and in conformity with the objects and nature of this trust:
- (xi) To give aid by way of donations out of the income or the corpus of the trust fund or otherwise to different charitable institutions, societies organizations or trust in India which may have been established or which may hereinafter be established of the like charitable purposes mentioned in these presents or any of them to enable such institutions, societies, organizations or trustees to start maintain or carry out such charitable objects.
- (xii) To settle all accounts and to compromise, abandon or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- (xiii) To borrow money either on the security of any property comprised in the trust fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the trustee to make such terms and conditions as they may in their absolute discretion think fit. The lender may be any individual, institution, bank, settler or trustee.
- (xiv) To apply to the government, public bodies, urban local municipal, district and other bodies, corporation, companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance including lease and substance of property with a view to promote the objects of the trust and to discuss and negotiate with government departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the trust and to put to any proper condition upon which such grants and other payments including taking land on lease may be made.
- (xv) To take over or amalgamate with any other Charitable Public Trust, Trust, association, or institution with similar objects.

- (xvii) To purchases or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies institutions or associations with which this Trust in authorized to amalgamate.
- (xviii) To take land / property on lease and then after sublease the land / property to the farmers and other organizations like co-operative / society / urban public bodies, / gram panchayat or any being there of in rural area / local municipal / district and other bodies corporation / company for farming / agriculture / plantation purposes.
- These Trustees shall be accountable only for such money, and funds, which will actually come into their hands.
- 11. The Trustees will not be entitled to receive any remuneration but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their relating thereto.
- 12. The Settler cum President for the time being will be liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and reappointment as the trustees for the time being consider proper. This will be done on hundred Rs. Stamp and it will be part of this Trust Deed.

#### 13. A PERSON SHALL CEASE TO BE A TRUSTEE EITHER:

- If he without leave of absence does not attend three consecutive meeting of the Trustees of for one calendar year whichever is longer or —
- If he is requested to resign by 2/3 rd or as near thereto as possible of the remaining trustees.
- Every Trustee will be at liberty to resign on giving on months' notice of his intention to do so.

The Trustees may from time to time frame rules of the conduct and regulations of the meetings of Trustees. In the absence of such regulations.—

- (a) Three Trustees shall form a quorum for a meeting of the Trustees.
- (B) All matters will be decided mutually by the Trustee.—

- (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid effectual as a Resolution duly passed at a meeting of Trustees.
- (d) Act means: Indian Trust Act 1882
- 15. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing constrained shall be deemed to authorized the Trustees to spend the income or coups of the Trust for any purpose not authorized by these present.
- The accounting year of the Trust shall be the financial year ending on 31st ( March every year.—
- 17. The Trust and the Trust shall stand forever. In case death of president and trustee the son & daughter Kunal and Jyotsna will automatically become president and trustee. Any change in trust deed can be made with the consent of alive members of the trust on one hundred stamp and this change will be part of this trust deed.
- 18. It is expressly declared that no part of the Trust property of its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions thereof shall be construed accordingly.—
- 19. Working areas of the trust will be all over India. -
- Two thirds majority shall continue the office of the Trust at Dehri-On-Sone (Rohtas) unless changed by the Trustees.

#### POWER & FUNCTION OF THE OFFICE BEARER.

#### SETTLER/PRESIDENT

The settler / President shall preside at all meeting of the trust, when he is present and shall exercise such other powers as are conferred upon him by these rules, the settler President signed notice in a shorter period. The decision of Settler President that a resolution has been carried or lost shall be conclusive, unless such a decision is challenged and a poll in demanded, on poll being demanded, the same shall be taken in such manner as the settler president shall have a second or casting vote.

- (a) He shall be in charge of the office and shall be responsible to general body in all matters. He will contract in all ways and means of the position of the association and shall right to improve it.
- (b) He shall be convener of all the meeting and without his signature on the notice of meetings no meetings will be valid.

- (c) It shall be his duty to see that the resolution at the respective meeting are implemented and give to effect too timely.
- (d) He shall be at liberty to spend for the purpose of the trustee without sanction of the settler President to do all such other lawful notes, deeds of things as incidental or conductive to the attachment of trustee.
- (e) He/She will be responsible to general body in all matter. He/She will contract in all ways and means of the position of the association and shall have right to improve it.
- (f) He/She shall product the accounts of the Trust before Executive Committee for approval.
- (g) If shall be his duty to see that the resolution at the respective meeting are implemented and give to effect to timely.
- (h) He/She will produce the expenditure of the trust before the Committee for approval.
- He/She will submit annual progress reports and audited statement of account of the trust before the general body meeting.
- He/She will guide direct and supervise all the activities of the Trust.
- (k) He/She shall place the financial position of the Trust in every meeting of the governing body.
- (I) He/She will receive grants, funds, donations and subscriptions on behalf of the

#### 22. INSPECTION OF REGISTERS:

All registers will be kept in the registered office. Any member may inspect these registers with the prior permission of the Settler President.

#### 23. AMENDMENTS:

Any additions, alterations, or omission in the objects and Rules and Regulation of the society shall be effected by resolution of the Trust by 3/5<sup>th</sup> member of the General body at a special general body meeting of the society.—

#### 24. LEGAL PROCEEDING:

The Trust may sue or be sued in the name of the settler President.-

#### 25. BANK OPERATION AND OPEUING OF ACCOUNT

Banks Accounts will be opened in the name of president and both trustee. It will be operated by president or jointly by both trustee.—

#### 26. DISSOLUTION:

a. The Trust shall be dissolved according to the Rules of the Trust Registration Act 1882 3/5 Majority of the member of the Trust in the General Body meeting.
